

Broken out by School Year


The SY23 20th day student enrollment is 322,106, representing a 2.5% (8,305 students) decrease in enrollment from SY22 and a 5.4% (18,552 students) decrease from SY21. Enrollment has decreased by 25.5% (82,137 students) since SY12.

Data Snapshot - Enrollment per School Type





*Prior to SY 2019-2020 charter school preschool enrollment was included in district enrollment counts. Starting in SY 2019-2020 these preschool students are captured by DFSS. All students enrolled in the Virtual Academy are tied to their brick and mortar schools for the purposes of 20th day reporting.

Broken out by Grade Level

Enrollment decreases in the past year are most prominent in middle and high school grades, especially 5th (-7.0%) and 7th (-6.2%) grades, while most other grade levels saw only slight decreases or stagnation. The exceptions are for PE (+8.5%), PK (+5.6%), as well as 10th grade (+2.4%) which all saw enrollment increases in SY23 compared to SY22.





Broken out by Race/Ethnicity

Overall the racial composition of the district has not changed.

In SY23, our Latinx (-2.8%) and Black (-3.1%) student populations continued to decrease at approximately the same rates as the previous year (-3.3%, -2.5% respectively). The number of Multiracial students also continued to increase (+5.4%) while Students of Other Races has decreased (-7.6%), although both student populations are much smaller in total number.

Over the past five years, despite sizable losses in our district enrollment, the racial and ethnic makeup of the district has remained remarkably flat.





Year-Over-Year Students In and Students Out


The number of students who left the district decreased by 6.0% from SY22 to SY23 after seeing an increase from SY21 to SY22; the number of new students joining the district also decreased by 3.0%, rebounding from a 35.3% increase the prior year. The decline in leaving students was not enough to offset the decline in new students, leading to the overall enrollment decline this year.





Year-Over-Year Students In and Students Out

The decline in enrollment for SY2023 of 8,305 is attributable to 42,230 students newly enrolling in the District and simultaneously 50,535 leaving the district, both through matriculation and other departures, between SY22-SY23.



Year-Over-Year Leave Code Usage

The decrease in students leaving the district is driven by fewer students transferring out. This is predominantly to schools outside Chicago (a decrease of 19.2% since SY22), to non-public schools in Chicago (down 19.6% since SY22), and homeschooling (halved since SY22). Drop Out leave codes and DNA leave codes (which should be interpreted as dropouts until schools enter a valid leave code) both increased over the past two years.












