Enclosed is a copy of the Agenda for the Finance and Audit Committee meeting to be held on Wednesday, January 27, 2021 from 9:00 a.m. – 10:00 a.m. The COVID-19 Pandemic has created a public health emergency in the City of Chicago and the State of Illinois.
