

President Vitale took the Chair and the meeting being called to order there were then:

**PRESENT:** Mr. Bienen, Dr. Hines\*, Mr. Ruiz, Ms. Pritzker, Mr. Sierra\*, Ms. Zopp, and  
President Vitale – 7

President Vitale thereupon opened the meeting.

Jean Claude Brizard, Chief Executive Officer, and Mr. Calvin Davis, Director of Sports  
Administration gave a presentation regarding the High School Physical Education Waiver  
Proposal. See Board Report to Approve Application for a Two Year Renewal of School Code  
Waiver Regarding Physical Education for Eleventh and Twelfth Grade Students [11-1109-EX1].

**APPROVE APPLICATION FOR A TWO YEAR RENEWAL OF A SCHOOL CODE WAIVER  
REGARDING PHYSICAL EDUCATION FOR ELEVENTH AND TWELFTH GRADE STUDENTS**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS:**

That the Board approve an application for a two year renewal of a waiver from Illinois School Code  
requirements regarding physical education for eleventh and twelfth grade students.

**CURRENT WAIVER:** The Board's current physical education ("P.E.") waiver for eleventh and twelfth  
grade students covers a five-year period commencing with the 2007-2008 school year expires at the end  
of the 2011-2012 school year.

**PHYSICAL EDUCATION REQUIREMENT:** The Illinois School Code requires daily P.E. but permits a  
school board to excuse, on an individual basis, eleventh and twelfth graders when he/she demonstrates  
any of the following:

1. ongoing participation in an interscholastic athletic program;
2. a need to enroll in academic classes for admission to an institution of higher learning, provided  
that failure to take such classes will result in the pupil being denied admission to the institution of  
his or her choice; or
3. a need to enroll in academic classes for graduation from high school, provided that failure to take  
such classes will result in the pupil being unable to graduate

**DISTRICT WAIVER REQUIREMENT:** Section 2-3.25g of the School Code permits districts to request  
waivers of School Code mandates when the applicant district demonstrates that it can address the intent  
of the mandate in a more effective, efficient or economical manner or when necessary to stimulate  
innovation or improve student performance. The Illinois State Board of Education (ISBE) submits waivers  
requested by districts to the General Assembly. If the General Assembly fails to disapprove a waiver  
request within 60 days, the waiver is deemed granted. Effective January 1, 2008, Section 2-3.25g of the  
School Code restricts waivers of physical education mandates to a maximum of three two-year waiver  
periods.

**PUBLIC HEARING AND NOTICES:** Section 2-3.25g(c) of the Illinois School Code requires the Board to  
convene a Special Board Meeting to consider a P.E. waiver renewal application and hear testimony from  
staff as well as interested parents and students. Notice of this Special Board Meeting was published in a  
Chicago newspaper and provided to state legislators representing Chicago and collective bargaining  
agents at least seven days in advance of this meeting.

**WAIVER TERM:** The waiver application requests a two-year renewal period which covers the 2012-2013 and 2013-2014 school years.

**DESCRIPTION OF WAIVER APPLICATION:** The application enumerates the reasons for seeking the waiver, namely to improve student performance by providing access to higher level courses and opportunities to satisfy graduation requirements. Further, a two-year waiver renewal supports the CEO's goal of transitioning PE 3 and 4 into the longer school day model for high schools.

**AUTHORIZATION:** Authorize the Chief Executive Officer to execute the physical education waiver application described above and submit it to ISBE in accordance with Section 2-3.25g of the School Code.

**Vice President Ruiz moved to adopt Board Report 11-1109-EX1 and was seconded by Board Member Zopp.**
