	The network has offered parents several learning opportunities to become involved including, Padres Comprometidos, a curriculum where I learned how to better support my children's learning. During these uncertain times when stress is a constant factor, the program gave me a greater understanding on the importance of mental health and provided me the tools to stay emotionally connected with my children. I have completed the curriculum twice now and I look forward to being a champion for Oscar and Edgar in their academic journey.
	At the start of the pandemic when we transitioned to remote learning, Acero was quick to offer the best academic support and kept my children engaged in their learning. The network has done an excellent job at keeping parents informed with the evolving health regulations and implementing safe health practices and sending out regular communications to parents. Acero has also informed families of important resources offered by community partners including testing & vaccination opportunities, food & housing resources and has hosted vaccination clinics throughout the Acero Network.
	I ask the Board today to recognize charter schools like Idar and see the impact they are having on families. Acero is more than a school, it is a community and resource for families.

7	We are a network of City of Chicago residents writing to share our concerns, as parents and taxpayers. It is in our sincere hope that the CPS BOE and superintendent will seriously consider our collective plea to offer a mask optional school environment. Collectively, while we acknowledge the challenges CPS faced in 2020-2021 and we know that administrators and educators did the very best for the sake of our children, we believe as data constantly is updated and changed, we as parents are in the best place to make decisions on whether our children should wear a mask in school.
8	It has been 2 years that my children have been subjected to your "contractual obligations". These mask rules were forced onto my kids without one tiny bit of conversation with myself or my husband. My 7 year old has not had ONE normal school year. They both suffer from sinus issues and when they show a hint of that at school they are humiliated and sent to the office to hurry up and have the school call me to pick them up because COVID clearly is killing all of your staff and the children in the schools, so we must not have any other option outside of forcing them into quarantine and shoving qtips into their brains in order to "clear" them of a virus that has now effected almost the entire human population and supposedly 70% of American people are now vaccinated - but that's not enough. As a parent of 3 children who have been forced to cover their mouths and noses for 8 hours a day, with only 20 minute food breaks, and a few minutes of "mask breaks" a day, I have reached my limit. I am the parent, and I am not in agreement with the school or the state determining what is best for my children. I should have the right as the parent to decide if I want to place a covering over my child's face as a safety concern, or if I feel that my child is safe enough based on our own circumstances of what we have already dealt with regarding this virus. Those who choose to wear a mask and vaccinate have that right and yet those who choose not to are forced to still comply with regulations that schools should no longer be enforcing. Last board meeting, a speaker pleaded with the board to do away with the CPS Residency Policy and I finally stopped laughing so I could type up a rebuttal to their plea.

See, the policy is 'Much Ado About Nothing' as the CPS Inspector General's office under William Flecther refuses to investigate several residency violators and they uncovered 1 violator in his 2021 annual report and 6 in 2020 out of total of 317 employee residency complaints

In fact, Fletcher's office has such a poor job of investigating that some violators have moved from one suburban home to another one.

Let's be clear here, I'm not alluding to CPS employees initially hired while living outside Chicago on renewable residency waivers for working in special need subject areas or those employees grandfathered-in with the old residency that allows them to live wherever they choose if they were hired before November 20, 1996. No, I'm talking about the employee residency violators that are lying and fraudulently living outside Chicago in clear violation of the residency policy.

The CPS OIG and other CPS leaders were given a confirmed list of close to 40 employees in violation multiple times over the past 2 1/2 years ago, including some employees in violation from 10-20 years. It's truly hard to figure why Fletcher's office refuses to investigate any of them.

Since the 2015-16 school year, one school (Steinmetz HS) had up to 24 employees in violation at one time working in their school with 5 of them being department chairs of program leaders. Let's give this the respect it deserves, "Steinmetz has had 24 residency violators working in their school since the 2015-16 school year. Yes 24!!!"

You might find 1-3 residency violators per CPS school, but nothing like the nonsense going on at Steinmetz.

The lack of a meaningful investigation by Fletcher and his staff into the 24 at Steinmetz in violation isn't righteous or fair to all the CPS employees that abide by the policy and pay city of Chicago property taxes.

I would like to go on record with my response to this blatantly deceptive email sent by CPS o Friday, February 18.

The appellate court did indicate that school districts are able to enact their own policies, however, they still must do so within the confines of state law. The ruling on February 4 indicated that all entities within the state are required to adhere to the IDPH Act, where there can be no forced quarantine, either mask or physical, without due process. The policies that CPS has in place violate this act as no parents and children have been provided the required due process under state law. The email sent by CPS is nothing other than a flat out lie. No court or state law/order has ever allowed them to circumvent due process rights. Staff members who are involved in violating state law, regardless of whether they are 'just following orders' are also liable.

I do not now, nor have I ever supported the masking of children and masking is the reason I withdrew 2 of my children from CPS in August 2020. Due to unforeseen circumstances, I unfortunately had to enroll my first grader in CPS this school year. Every day I tell my daughter not to wear her mask at school, but when she is told to put it on she does so. She wants nothing more than to see her friends smile, but due to policies that are not only misguided, but harmful and not based on any fact, she has been deprived such a basic right and desire.

Unfortunately, the continued false rhetoric that masking prevents viral spread and that Covid is equally as dangerous to everyone is still very much alive with the city of Chicago.

1. Masks do not work. Please refer to the >340,000 participant randomized clinical trial in Bangladesh (https://doi.org/10.1126/science.abi9069). At best, the use of masks found a 9.5% reduction in Covid-19 symptoms, yet only captured a difference in positive Covid test of 0.08% between the masked and non-masked groups. The CDC has now even indicated that only N95 masksare capable of potentially limiting the spread of Omicron, which indicates that masks have been completely ineffective up to this point. The virus did not all of a sudden be able to penetrate through cloth/surgical masks, it has always been able to and only provided people with a false sense of security, the ramifications of which are already being seen in the huge increases in both adults and children with mask related anxiety.

2. The CDC's own data has consistently shown that the risk of death from Covid-19 is extremely small for those under age 65 (https://www.cdc.gov/coronavirus/2019-ncov/cases-updates/burden.html). This data shows there is only a 0.17% risk of death for those under the age of 65, with the 0-17 year age group having a nearly non-existent risk of death at only 0.002%. Imposing restrictions on individuals who are healthy and at a very low risk of death is non-sensical, but also a violation of individual rights. Masking of children with a risk of death from Covid that is nearly non-existent is not only unnecessary, it is plain and simply wrong.

This serves as your notice that I am pursuing legal action against the BOE, CPS, CTU, as well as any individual staff members who continue to violate my child's right. The rights of children and parents are not, and have never been subject to bargaining. You CANNOT bargain my child's rights away and I will no longer stand for the blatant disregard for laws and individual rights.

I am a CPS parent of two young elementary students. I am writing today to voice my hope that CPS will adopt a mask-optional policy in schools as quickly as local health guidelines allow. School-aged children have had widespread vaccine access since November 2021, and adults have had vaccine access for over a year. I'm writing in support of the fight for Chicago Public Schools to be successful and safe. I'm asking that the board demand our schools be kept safe by supporting the mandate of wearing masks while inside our schools. This is the minimum requirement for reducing the number of Covid victims going forward. School is an essential part of our democracy and our society. It shapes how we grow up, how we parent, how we organize our work, and how we develop and connect as citizens. We expect Board members to do everything in their power to ensure the long-term availability, stability, and integrity of these institutions.

For nearly two years, pandemic conditions have forced administrators into the unprecedented decision of replacing in-person schooling with virtual remote instruction, whether in the form of systemwide closures or rolling quarantines. While plausibly necessary in the early days of the pandemic, there is no scientific ambiguity about the negative effects of this historic shift in K-12 education: school closures and quarantines have proven ineffective at curbing the spread of COVID-19 while proving extremely effective at curbing the intellectual and social health of kids and the economic health of households.

Against the shifting scene of pandemic conditions, CPS's current policy- which automatically sends unvaccinated "close contacts" of a COVID-19-positive peer home for 10 days of remote learning- is unscientific, unethical, and unfair. With its constant threat of keeping healthy kids home for no reason, CPS policy continues to erode public confidence in our schools, hitting working families and poor families with extra force. Since September, between 4,000 and 23,000 kids have been kept home every day.

Test-to-Stay would end this misguided policy, allowing such students to stay in school, so long as testing yields a series of negative COVID-19 results. As parents and community members, we demand that the Chicago Public Schools move toward immediate adoption and implementation of a Test-to-Stay policy for students who have been identified as exposed to a COVID-19-positive peer.

Our view is simple: Only a child who is sick with COVID symptoms or has a confirmed positive test should ever need to be excluded from school. Test-to-Stay provides the relevant data, enacts a safety procedure on that basis alone, and allows us to minimize the disruptions and stratifications that COVID (and misguided COVID policy) have enacted on our city.

As we all hope for COVID's ultimate passage from a pandemic to an endemic stage, parents, teachers, and citizens need to stand by the pillars of our civic life, and resist the temptation to relapse into modes of panic or paranoia.

On the Costs and Burdens of Remote Learning

Weighed against the obvious benefits of active, thriving school communities, CPS' current quarantine policy is ill-fitted to the realities of the pandemic, imposing a rolling schedule of child-care emergencies on parents, and needlessly interrupting the intellectual and social development of our children. With only 40 documented instances of transmission within Chicago schools since September and less than two percent of quarantined kids ultimately contracting the virus, the public health benefits of intermittent mass quarantines are dubious. Meanwhile, the lost wages, lost learning, and replacement of social life with screen-time are measurably bad news for kids and families.

On the Social Injustice of Quarantines

	Current policy has effectively created two tiers of educational access in Chicago, using a blunt and in light of the transmissibility of current variants irrespective of vaccination status scientifically irrelevant data point to exclude masses of kids with no symptoms or positive test results from schooling. You don't need to look at a map to guess where the heaviest count of unnecessary exclusions are landing. Working families and poor families will continue to be hit hardest by the current policy.
	On Chicago being Out of Step with National Policy Amid the rise and fall of the latest omicron surge, school districts nationwide, including New York City, Los Angeles, Cleveland, and Atlanta, have ended their use of rolling quarantines for cases of close contact. Chicago stands outnumbered in its inability or unwillingness to do the same; the city's Test-To-Stay pilot, initiated in November, operates at a single schoolhouse, while thousands of children continue to be excluded from school on a daily basis. On the Politics
	The wisdom of maintaining in-person schooling is being embraced irrespective of political party. No matter if you usually root for Republicans or Democrats, progressives or conservatives, we should all welcome support of good public policy!
	In the recent agreement that ended the 5-day stoppage of classes, BOTH CPS and CTU affirmed the intent to "promote" the Test-to-Stay pilot, which is currently only active at one school. The Board needs to turn this unique point of agreement into policy.
	On the Science A Test-to-Stay policy represents the most responsible and scientifically supported approach to safeguarding the health of our children and educators while also ensuring the integrity and stability of our institutions of public schooling. The Federal Centers for Disease Control, the Illinois State Board of Education, the Illinois Department of Public Health, and the Chicago Department of Public Health have specifically authorized a Test-to-Stay protocol as part of official Guidance for COVID-19 Prevention in K-12 Schools.
16	It is time to start following the judges order and unmask our children. It should not be up to the school district if our children should be masked or not, this is something that falls on the parents. Hundreds of schools have gone mask optional since the judges order and CPS should be no different. What you are doing is illegal and even the judge said so. Drop the mask mandate in all of Chicago Public Schools and leave it up to the parents!
17	On behalf of the Englewood Community Action Council (CAC.) We are honored to write this letter of support for the renewal of the charter for Englewood Urban Prep. Englewood Urban Prep is a valuable asset to the Englewood community and provides an excellent educational option for young men of color. Englewood Urban Prep provides an educational choice to families that offers rigorous academics, core values and high standards, which prepares students for success in college and career, and creates contributing connected citizens. Urban Prep is not just a successful high school it has become an important part of the Englewood community. Urban Prep works with community organizations including the Englewood CAC to improve the quality of life of Englewood families.

However, Englewood Urban Prep is perpetually locked in the renewal process. This process is taking away from educating the young men of this community. A 5-year charter renewal can help the school be successful. Anything less than a 5-year renewal does not provide stability for school staff, students, families or the Englewood community. A 5-year renewal will allow the school to create a 5-year strategic plan that would outline goals and objectives for school continuous improvement and advancement. Without a 5-year renewal the school is constantly in a state of preparing to renew staff members don't feel stable because the school is always in a state of charter renewal, and this is not productive for students. This Wednesday, you will be asked to vote on 22-0223-RS2. The resolution has two parts. The first ratifies the entirety of CPS' current COVID policy approach, and the second authorizes the delegation of any future decisions regarding changes to COVID policy to the CEO. I urge you to vote NO on this resolution. Were it to pass, it would constitute an abdication of authority by the Board and a breach of the public trust placed in its members.

As regards the first part of the resolution, ratifying the current basket of COVID mitigations is precisely the opposite of what the Board ought to do in light of shifting public health conditions. Parents demand careful oversight, not rubber stamps. In addition to containing misrepresentations of current CDC, IDPH, and CDPH guidance (specifically as regards quarantines for all unvaccinated persons exposed to COVID-19 and universal masking), the resolution presents no basis for supporting its broad assertion that all of CPS's current mitigation strategies are "curb[ing] the spread of COVID-19." Questions about the legality and efficacy of any of the current layers of mitigation are ignored entirely, as are the widely understood disruptions and harms that their prolonged use continues to impose on kids and families.

As regards the second part of the resolution, the text is even more troubling. The resolution asserts the Board's "broad authority" and then surrenders it voluntarily and completely. In its proposed delegation of all decisions related to COVID to the CEO and public health officials (and vaguely invoked consultations with stakeholders), the resolution asks the Board to seal itself off from further deliberation on the question, effectively firewalling the public off from the opportunity to meaningfully speak its voice or exert its will. In no uncertain terms, the resolution snuffs out any sense we might have of the Board of Education as a mechanism of democratic accountability.

Given the historically unprecedented disruptions to public schooling that COVID and COVID policy have occasioned, we expect you as a Board member to step boldly into your role as overseer of our public institutions, to assess frankly the costs and benefits of public health protocols, and to enact the will of the people when we demand a drawdown of unnecessary mitigations. 22-0223-RS2 would make it permanently impossible for you to do your job. Vote NO on Wednesday.

Dear Chicago Board of Education,

I call on you today to put an end to the universal masking requirement in our schools, or at the very least announce a reasonable, attainable set of metrics that, once met, will allow all Chicago Public School students to return to the much needed and deserved sense of normalcy of their pre-pandemic lives.

Illinois and the city of Chicago will drop their indoor mask mandates for most public places on February 28th. Of the 850 school districts in Illinois, 700, of 82%, have already moved to mask optional policies, or are about to in the weeks ahead. School mask mandates are also dropping across the country and around the world. Schools that have removed mask mandates, or have never required masks from the start, have not experienced any reported large-scale outbreaks, nor has the removal of masks caused any disruption to their in-person learning. Why do our Chicago Public School children not deserve the same opportunity - to have a normal school experience, and to heal from the mental toll they've carried these last two years - as the rest of students in Illinois and beyond?

An email from Chicago Public Schools on February 22, 2022 states universal masking will remain in place at this time, with no set timeline on when this may change. One of the reasons given is there is still a great deal of anxiety about covid in our community. This fear is real, but it is not grounded in science, and we must not let fear drive decisions that are critical to the well-being of our children. Public health officials have said from the beginning, children have the lowest risk of becoming seriously ill from Covid. This was true before vaccines were widely available, and with vaccines, kids are incredibly well protected. Yet our school children, the population with the lowest risk. must continue living with the tightest restrictions. Under the guidelines beginning February 28, it will be ok for a group of elderly unvaccinated adults, those at greatest risk, to gather in a public venue in Chicago without masks, but at school our children, whose risk from Covid is minuscule, may not. It is commonly said that while children may be at low risk, they may still contract Covid and spread it to others in their homes. Yet the same reasoning can be applied to adults who will soon be free to mingle about society unmasked; they may go home and spread Covid to their at-risk loved ones as well. Children are unfairly considered to be vectors of the virus yet there is no scientific or logical explanation that supports this. On the contrary, the universal masking mandate in our schools is mired much more in politics than it is science. It is unreasonable and unfair to our school children that their welfare is at stake amidst the ongoing bargaining tensions between CPS and CTU, or perhaps more accurately, the unwillingness of CPS to upset the current collective bargaining agreement, for fear it may spark another strike or work stoppage. We cannot continue to let the demands of the CTU hold our children back while the rest of the world happily moves on, showing us it is clearly safe to do so.

This is not the first time we've seen the politics between CPS and CTU play out like this. Exactly one year ago it was school reopening that the CTU fought mightily against, convinced it would set off a record number of cases and have deadly consequences. Similarly, the rest of the world had already moved to in-person learning, showing us what was safely possible, but it was a long arduous fight for Chicago's kids. Upon finally reopening, none of the fears that held our kids back for so long from attending in-person school actually came to fruition. And the damage to our kids of a full year of remote learning had already been done.

Is it not clear to you, Chicago Board of Education members, what is plainly happening here, again, when it is absolutely crystal clear to us parents? This is why so many of us are coming forward to speak out against masks at this point. Thinly veiled as a measure to protect our kids and necessary keep our community safe, masks are a political weapon and our kids are the prisoners. There are no longer any scientific reasons supporting the mask mandates in schools for CPS kids, only fear-driven excuses. Let me paint for you another fear-driven argument. If we continue choosing to not keep pace with the rest of Illinois and the world in removing unnecessary covid measures, families with means - money to donate, time to volunteer - will leave the city in droves, worsening educational inequities, lowering property values, and driving up poorer socio-economic conditions for those who remain.

Another reason for keeping mask mandates in place per the February 22 CPS email states that schools are not like other indoor spaces; they require students and staff to be together in close quarters for many hours each day, raising the risk of viral transmission when masks are removed. Yet other schools have managed to lift mask mandates without dire consequences, proving schools can be unmasked successfully. Consider the United Kingdom, who never required masks for younger school children from the beginning of the pandemic. Consider other public places where people come into contact with others all day long, such as grocery stores and other retails outlets and warehouses. Yet Amazon, Walmart, and Target, among others, have recently announced they have lifted mask mandates for their workers. With so many examples of schools and other places with similar indoor settings successfully moving forward, this argument from CPS holds no weight.

We are no longer living in the panicked spring of 2020, when we raced to take all precautions necessary to keep the population safe from the novel coronavirus, given the lack of information and nary the hope of a vaccine. This was all understandable at the time. Masks were widely accepted and worn by the general public, and they were meant to be temporary. Over the last two years, much has changed, including the wide availability of vaccines and various medical treatments. The knowledge we have is greater, and the opportunities to protect ourselves are greater. It only makes sense, given where we are at this point in time, that we evolve the mitigations we have in place with the goal to return life to normal as guickly as possible, and remove mitigations where the risks are beginning to outweigh the benefits. We are seeing progress being made for all Illinoisans, and all Chicagoans, but this unfairly excludes our children, with no end in sight. We cannot possibly think it appropriate that our children remain masked - while adults are free to do as they please - until an unspecified time in the future when either Covid goes away, which will never will happen, or when pediatric vaccinations increase to the level that satisfies our school officials, which will also never happen, barring any vaccine mandate. We must acknowledge that parents who haven't already chosen to vaccinate their children by this point, likely never will. We cannot continue

asking our kids to wait for them to change their minds. With these as our goalposts, our kids will be masked for the rest of their school lives. Our kids deserve to have a normal school and life experience, before they age out of school and this is all they've ever known or experienced. Please consider that our kids are already quickly approaching that reality, when the the last normal full school year for kids who are currently in 4th grade was in 1st, and for kids who are currently freshmen in high school, it was 6th.

Our children are the future of this city. For their mental health and well being, it is time to put an end to mask mandates that for the long term are more disruptive to our students' academic learning and social development than they are protecting them from the virus - a virus from which they are already naturally well protected, and even more so with the vaccine, should they choose. While the rest of the state, country, and world move forward, Chicago Public School kids will be left further behind. This is not fair, appropriate, nor equitable. In light of all presented above, our kids deserve to reclaim the same normalcy we're on the cusp of granting to all Chicago adults, that millions of school-children outside of Chicago already have, lest the cure we've imposed upon our kids become much worse than the disease itself.

I ask that you seriously consider the weight of your decision regarding mask mandates on our kids, and to strongly consider the words above as you continue to evolve these policies. Thank you very much for your time.

She has also worn a mask at day care and school since June of 2020 with no complaints. She understands that the masks protect her and the other kids, and though it isn't always easy to wear one, she knows that it is important. I have difficulty understanding why adults are so quick to say that kids are tired of masks when my daughter has worn one for years with no issue. I hope that the Chicago Public Schools will continue to require masks and help provide vaccinations until the positivity rates are lower and all of the kids who can get vaccinated are vaccinated. Thank you for listening.
62	My family and I are in agreement that we support the CPS decision to keep mask mandates for all students, staff, and teachers K-12 through the remainder of this school year. Please care for those among us who are immunocompromised.
63	GET RID OF THE MASKS! Why are we the last ones to lift it!?!
64	I urge the board to keep the mask mandate in place at all CPS schools for the remainder of the school year. Wearing a mask is a small price to pay to protect the health and safety of immunocompromised students and staff and to keep the COVID-19 transmission rates low.
65	Greetings, I am a parent to a CPS 2nd grader and I support continued masking in our schools until the end of the school year. I am in favor of a covid vaccine requirement for all students and staff by fall 2022. Good Morning President del Valle, esteemed Board Members and Dr. Martinez.

My name is Yennya Segura and I am honored to be here today and share with you the amazing work Acero Schools is doing. I have two students that attend Jovita Idar in the Gage Park Community, Oscar Godinez in 2nd grade and Edgar Godinez who is in 6th grade.

My children and I love Idar and consider it a second home. I am blessed to have a school that has allowed me to partake in my children's learning experience. I have volunteered at Idar and engaged in several activities including supporting our office coordinator at the front desk and learning new clerical skills, participating in yearly school celebrations, and helped establish a community library for our spanish speaking families and continue to support by being involved with the after school reading club.

The network has offered parents several learning opportunities to become involved including, *Padres Comprometidos*, a curriculum where I learned how to better support my children's learning. During these uncertain times when stress is a constant factor, the program gave me a greater understanding on the importance of mental health and provided me the tools to stay emotionally connected with my children. I have completed the curriculum twice now and I look forward to being a champion for Oscar and Edgar in their academic journey.

At the start of the pandemic when we transitioned to remote learning, Acero was quick to offer the best academic support and kept my children engaged in their learning. The network has done an excellent job at keeping parents informed with the evolving health regulations and implementing safe health practices and sending out regular communications to parents. Acero has also informed families of important resources offered by community partners including testing & vaccination opportunities, food & housing resources and has hosted vaccination clinics throughout the Acero Network.

Last board meeting, a speaker pleaded with the board to do away with the CPS Residency Policy and I finally stopped laughing so I could type up a rebuttal to their plea.

See, the policy is 'Much Ado About Nothing' as the CPS Inspector General's office under William Flecther refuses to investigate several residency violators and they uncovered **1** violator in his 2021 annual report and **6** in 2020 out of total of 317 employee residency complaints

In fact, Fletcher's office has such a **poor** job of investigating that some violators have moved from one suburban home to another one.

Let's be clear here, I'm not alluding to CPS employees initially hired while living outside Chicago on renewable residency waivers for working in special need subject areas or those employees grandfathered-in with the old residency that allows them to live wherever they choose if they were hired before November 20, 1996. No, I'm talking about the employee residency violators that are lying and fraudulently living outside Chicago in clear violation of the residency policy.

The CPS OIG and other CPS leaders were given a confirmed list of close to **40 employees** in violation multiple times over the past 2 1/2 years ago, including some employees in violation from 10-20 years. It's truly hard to figure why Fletcher's office refuses to investigate any of them.

Since the 2015-16 school year, one school (**Steinmetz HS**) had up to 24 employees in violation at one time working in their school with **5** of them being department chairs of program leaders. Let's give this the respect it deserves, "**Steinmetz has had 24** residency violators working in their school since the 2015-16 school year. Yes 24!!!"

You might find 1-3 residency violators per CPS school, but nothing like the nonsense going on at Steinmetz.

The lack of a meaningful investigation by Fletcher and his staff into the **24** at Steinmetz in violation isn't righteous or fair to all the CPS employees that abide by the policy and pay city of Chicago property taxes.

Introduction: The Urgency of Equity

As the COVID-19 pandemic continues, we are continually reminded that we live, work, and learn together in communities. In this world of shared breath, it is a practical and moral urgency that we protect the most vulnerable among us — low-income people, elderly, the disabled and immunocompromised, and Indigenous, Black and Latinx communities, among others — who have been disproportionately harmed by the impact of COVID-19.

As microcosms of our community, schools reflect broader inequalities. We all want students to be safe and able to learn: evidence suggests that the best way to ensure the safety of students, teachers and staff and to keep schools open is to use layers of protection.

These include paid sick leave for staff, mental health care for staff and students, coordinated ventilation and filtration efforts, sustained access to the best quality masks and testing, as well as proactive efforts to keep community viral levels low. These are inevitably political demands of our local, state, and federal governments and require vocal public support. As COVID-19 rates allow, we can alter protections — and bring them back if needed. Having a plan to use data to inform these decisions helps ensure that protections are sufficient to safeguard the most vulnerable.



Introduction: The Urgency of Equity

As schools face continuing questions about sustainably protecting even the most vulnerable groups from COVID, this toolkit aims to provide accurate, fact-checked information and up-to-date research summaries to help schools and communities make decisions that will keep ALL members of school communities safe. This toolkit emphasizes ways we can prioritize health and well-being in our schools, recognizing that collective, rather than individual, approaches are the best way to mitigate the harms of an airborne virus.

Normal should not mean accepting perpetually high rates of COVID-related illness, chronic disability, and death. The turbulence of the pandemic can motivate us to recognize and rectify pre-existing disparities. Two years into the pandemic, we have the knowledge and means to do just that. We can take measures to keep schools and communities safer and begin to move towards a new normal–one that values the lives of our most vulnerable members.



Urgency Of This Moment: Pediatric Hospitalizations


- School plans must be centered on protecting the whole community, including those placed at highest risk.

Urgency Of This Moment: High Case Rates

- Even as we move past the worst of the Omicron surge, cases remain incredibly high across the nation.
- The CDC defines low community transmission as <10 cases per 100,000 and < 5% positivity.

Urgency Of This Moment: Caregiver Deaths

- Healthy schools mean fewer children bringing the virus home to their families where it can spread to other vulnerable family members, including grandparents and younger siblings.
- Over 200,000 children have lost a caregiver during the pandemic, causing emotional stress, poor mental health, and severe disruptions to learning. Black and Latinx children have been disproportionately impacted. Even more students have had a caregiver hospitalized or suffering from long COVID.
- Tragically, more than **400 teachers have died** from COVID.


COVID-19 is an airborne virus.

Clean air and masks are essential to stopping its spread.

Fact: COVID is airborne. It spreads through the air we breathe.

Concern: Public health guidance early in the pandemic told us COVID spread primarily through droplets, emphasizing the importance of six-feet of social distance at the expense of cleaning and regulating indoor air.

- Airborne transmission means that individuals are primarily infected through inhaling aerosols containing the virus. These are produced when an infected person exhales, speaks, shouts, sings, sneezes, or coughs.
- A cough or sneeze can propel COVID particles up to 12 feet. Even exhaled aerosols can fill indoor spaces rapidly and be recirculated by ventilation systems. Laboratory experiments suggest that the exhaled infectious virus can remain suspended in the air for prolonged periods of time.*



• Cleaning indoor air is essential to reducing COVID's spread & masks reduce the amount of virus in the air.



COVID-19 is Airborne: Multiple layers of protection keep schools safer.

- 1. Keeping community transmission low will keep schools safer for all students and staff.
- 2. **Increase vaccination rates** among students, staff, and teachers; encourage everyone to get their COVID vaccinations and boosters as advised by the CDC.
- 3. **Improve ventilation and air filtration** in schools by both opening windows (wherever possible) and filtering indoor air using HEPA air purifiers. Monitor air quality with CO2 monitors when possible. Move activities (especially lunch) **outdoors** whenever possible.
- 4. Provide and encourage wearing high-quality masks (N95/KF94/KN95) for all students, teachers, and staff.
- 5. Use **universal at-least weekly testing** for students, teachers and school staff. When individuals are experiencing symptoms or test positive, stay home for the full ten day isolation period. For those who want to or have to exit isolation early,* negative rapid tests on two consecutive days (no earlier than day 5) should be used to guide their decision making.




VAXPLUS COALITION Adapted from Ian M Mackay Based on the Swiss Cheese Model of Accident Causation, by James T Reason 1990

COVID-19 is airborne: Improving indoor air ventilation and filtration makes schools safer.


Air ventilation and filtration go hand-in-hand. As with the Swiss cheese model, more layers increase protection:

- Opening windows is a free and accessible way to improve ventilation (in locations where this is possible).
- HEPA Air Purifiers and Corsi-Rosenthal boxes are recommended to filter infectious virus and other air pollution from air in classrooms.
- Some school districts are using CO2 monitors to assess air ventilation. CO2 levels should ideally be close to outside air quality, at <800ppm.

COVID-19 is Airborne: Air Purifiers Help Clean Indoor Air.



Corsi-Rosenthal Boxes are low-cost DIY Air Purifiers, which are are effective and can be made by parents or staff. HEPA Air purifiers – consumer and DIY -- can also be used in homes to limit the spread of COVID in the home if one person gets sick. This is especially critical for multi-generational households and those with immunocompromised and vulnerable household members.



COVID-19 can cause severe and chronic illness, disability, and death.

Fact: COVID-19 is far more serious for children than the flu.

Concern: Some have advocated for the removal of masks and other protections for students, claiming COVID-19 is no more dangerous than the flu. But these claims are not supported by the evidence.

- Over the pandemic, more than 1,200 children have died from COVID-19 in the US.
- Over the same time frame, fewer than 10 flu-related childhood deaths have been reported.*
 - Before the pandemic, fewer than 200 children died from the flu each year.
 - *5 flu deaths have been reported so far in 2021-22

Fact: Children can develop Long COVID.

Concern: Some claim that COVID-19 is not a serious concern for children and dismiss the reality of children developing Long COVID

- A growing body of research shows many adults **and** children develop Long COVID.
- Long COVID sufferers experience a wide range of long-term symptoms and conditions after a COVID-19 infection, often after mild or fully asymptomatic infections.
- Studies have shown multiple organs can be affected, including brain, kidneys, lungs, and the heart.

Fact: Long COVID can have serious effects on children's health & learning.

- Symptoms and disability can impact children's everyday life, often making it difficult to attend school or participate in extracurricular activities.
- Long COVID is recognized federally (Section 504 and IDEA), with guidance on how schools should support students with Long COVID.
- Preventing Long COVID by reducing COVID infections is important for students' learning and current and long-term health.
- Children are not the only ones at risk in schools. Teachers and school staff can also develop Long COVID.



Fact: Multisystem Inflammatory Syndrome (MIS-C) is a Serious Consequence of COVID-19 for Many Children

- MIS-C is a rare but serious condition that appears in some school-aged children 2 to 6 weeks after a COVID-19 infection.
- A total of 6,851 MIS-C cases and 59 MIS-C Deaths (meeting case definition) have been reported as of January 31, 2022

Reported MIS-C Case Ranges by Jurisdiction, on or before January 31, 2022*






Vaccines help protect against severe disease and death, but too few children are vaccinated.

Fact: Right now, child vaccination rates are low.

Vaccination helps prevent serious acute infections in children. Vaccination rates must be improved.


- Less than 60% of students 12-17 years old are fully vaccinated.
- Less than 25% of students 5-11 years old are fully vaccinated.
- Racial and ethnic minority students are less likely to have had access to vaccines.
- The choice to be vaccinated is often not up to students.
- Children under 5 are not yet eligible for vaccination.



Note: fully vaccinated here means the original series only; the proportion of people with boosters is even lower.

Reducing the spread and impact of COVID on children and their families is an important part of protecting their mental health.

Fact: COVID-19 has been a stress on children and families, but it has **not caused a spike in child suicide rates**.



Suicide rates in the pediatric population have been increasing since 2007, and there was no rapid spike during the pandemic.

Note: for boys, suicides decreased during the pandemic compared to 2017-18. Overall, the rates during the pandemic followed the same pre-pandemic trends.






American Mental Health ER Visits

Canadian Mental Health ER Visits






Both American Emergency Departments (National Syndromic Surveillance Program) and Canadian Emergency Departments (Ontario) have shown no increase in emergency visits for mental health-related concerns. Some subgroups have shown increases (girls with eating disorders), while some groups have shown decreases (boys for all reasons, girls with bipolar disorder).

Fact: While distress in children has undeniably risen, mental health impacts have been mixed.


- While many early studies show high levels of anxiety & depressive symptoms ("doubling"), these studies were mostly of *low quality*. Typically *higher quality studies* show a smaller effect.¹
- Better, longitudinal studies provide even more detailed information. Surveys of the United Kingdom, Canada, and the United States have shown both increases and decreases in mental health impacts.²

Fact: Most evidence shows that there are minimal impacts of remote learning on children's mental health.

A CDC Survey of Parents revealed few differences between how parents saw their children's symptoms of depression, anxiety, and psychological stress between different forms of schooling during the early pandemic.

Fact: Masks do not lead to learning loss in students.

Concern: There have been unsubstantiated claims that masks make it more difficult for students to learn or read emotions. There is no evidence to support these claims.

- There is no empirical evidence showing that masks interfere with student learning and social-emotional development.
- Based on a review of available literature, The South Carolina Department of Health concluded "No data regarding the impact of mask wearing on children's academic development or performance was identified during a thorough scientific literature review.
- Experts agree, including the AAP, who notes, "Masks will not affect your child's ability to focus or learn in school." Schools should support any students who are struggling with learning during this pandemic.

Fact: COVID-19 itself has devastating impacts on experiences of death and dying on children


Concern: Some claim that any mental distress experienced by students during the pandemic is due to protections, like masking and remote school. This ignores the impact of the pandemic itself on students' lives.

- A study using data to April 2021 estimated that globally, 1,134,000 children lost a primary caregiver (at least one parent or *custodial* grandparent), and 1,562,000 children lost at least one primary or secondary caregiver. In the United States alone, 113,000 children were estimated to have lost a primary caregiver by April 2021.
- Currently over 200,000 children in the U.S. have lost a primary caregiver.
- 35% of family members of patients who had ICU-level acute respiratory distress experienced PTSD-related symptoms 90 days later.

Fact: Masks reduce COVID-19 spread.

Concern: Some argue that masks should be abandoned as a protection strategy, claiming there is no evidence of the benefits of masks

 Lab testing shows masks reduce exposure to potentially infectious aerosols Wearing a mask that fits tightly to your face can help limit spread of the virus that causes COVID-19



Fact: Masks reduce COVID-19 spread.

- As indicated in the summary table to the right, real-world studies using various designs show masks reduce COVID transmission across many settings.
- A large randomized controlled trial (RCT) in Bangladesh showed masks reduced transmission in the community. Specifically, they found surgical masks were more effective than cloth masks, but did not examine higher-quality masks.



Fact: Universal Masking reduces the amount of COVID in the air.

Concern: Some are calling for "one-way" masking, requiring only those who are vulnerable or concerned about COVID-19 to wear masks.

- High-quality, well-fitting masks protect both the person wearing them and those around them; together, the protection is much stronger.
- Universal masking avoids stigmatizing children with high-risk conditions or those trying to protect their family or other household members.



Fact: Masks mandates have been associated with decreased rates of COVID-19.

- Multiple studies comparing cases before and after states implemented mask mandates show that masks mandates work.
- A CDC study found increases in pediatric COVID-19 case rates during the start of the 2021–22 school year were smaller in U.S. counties with school mask requirements than in those without school mask requirements.
- Data-driven mask mandates can be turned on and off depending on local factors including COVID positivity rates, vaccination, and other factors.
- Data-driven mask mandates **are especially important in communities of color** where many children live in multigenerational and densely populated households.

Testing helps keep schools safer and informs decision making.


Fact: Weekly screening can help keep schools safer.

Concern: Some suggest schools should no longer test students and staff for COVID-19.

- Routine school screening and properly implemented test-to-stay programs are effective ways to help prevent outbreaks in schools.
- For instance, testing in Los Angeles Public Schools before returning after winter break found >65,000 positive students and staff, who could have otherwise brought COVID-19 into schools.
- Regular testing also helps school leaders make informed decisions about how and when to change protections.
- School testing can increase access to testing for lower-income households, who may not be able to afford at-home test kits.

Single antigen testing Pooled PCR testing Serial antigen testing





How to Make Data-Driven Decisions to Change COVID Protections

A recent modeling study found that widespread weekly screening can allow schools to safely remove other layers of protection - if community cases are appropriately low:

"Screening of asymptomatic students, educators, and staff may be another tool to support more permissive off-ramps when unmasking is strongly desired. Weekly screening decreased the additional modeled cases associated with mitigation relaxation compared with only diagnostic testing (Figure 4A), approximately doubling the local incidence thresholds for removing other mitigation measures (eTable 4 in the <u>Supplement</u>), but schools need to weigh the cost of screening against these benefits. <u>Weekly screening</u> <u>after unmasking may also provide valuable information</u> <u>about the consequences of this change in an individual</u> <u>school.</u>" Figure 4. 

Conclusion

- COVID-19 remains a serious health threat to our students, their school staff, and their communities.
- Reducing COVID-19 protections in schools should be done when community case rates are low and vaccination rates are high*, in collaboration with and in consideration of the most vulnerable members of the community.
- Schools should have a plan in place to assess whether changing protections result in increases in case rates and a plan to return protections when community rates increase again.
- We have tools including high-quality masks, affordable ventilation options, testing and quarantine to keep schools safer. We must advocate for their increased funding and use, as well as for structural improvements around better pay and sick leave, access to testing, long-term ventilation upgrades (in our schools and our communities), ongoing protections for vulnerable students and staff, and accommodations for students with Long COVID.
- We have tools from the fields of neuroscience, developmental psychology, and education to address instructional loss and provide enrichment experiences to support students and help them develop additional skills to meet their benchmarks. We must trust our educators in doing their job and support our learning communities.
- We can work together towards a new normal which addresses and combats the pre-existing disparities with which we
 entered this pandemic. By working for safer schools and communities, we can build a new normal which puts the lives of
 those most vulnerable low income people, immunocompromised and disabled, Indigenous, Black and Latinx, among
 others first.

*This model provides guidance for when to change school protections, depending community rates and the goals of the district - preventing more cases and/or preventing hospitalizations; it is important to consider that class size, vaccination rates, and other assumptions in the model when applying to actual school districts. <u>https://iamanetwork.com/journals/jamanetworkopen/fullarticle/2789005</u>
