Good afternoon. My name is Donald Davis, a resident of the East Side and 10th Ward for the past 18 years. I am a National Board certified Social Science teacher with 22 years experience teaching at neighborhood high schools in CPS. The last 8 years I have taught at George Washington H.S., just five minutes from my house. I'm speaking today to demand that the Board of Education consider the needs of my community and school in funding a NEW school building and athletic facilities for Washington H.S. On the last day of school with students in June, part of the second floor ceiling collapsed, injuring a staff member. We were very fortunate that no one else was injured by this			
Our school has seen increased enrollment of a couple hundred students over the past few years, and as a result is said to be at 118% capacity. We have a run-down mobile unit with half of the room a/c units not functioning, and we lack central air in the hallways and common spaces like the student lunchroom, auditorium, and offices. Many windows are bolted shut and broken. Cabinets and doors to classrooms are run down as well. Hallways are crowded, students worry about their safety, and we lack sufficient space to accommodate our diverse learners, English learners, and parent and teacher meetings.			
Yet Washington H.S. has been celebrated as a Democracy School by the McCormick Foundation. We have the highest on-track rate in our network with a top-ranked IB program and many AP and Dual Credit courses to allow students to earn college credits before graduation. Meanwhile our volleyball, baseball and softball, E-sports, and soccer teams have experienced considerable success over the past decade. Our boys soccer team finished 3rd in the State, which the Board recognized and celebrated. Yet our teams have to travel three miles to Calumet Park for practices and matches, while competing with other teams for the space even though we pay to reserve it. CPS and the City of Chicago express a commitment to reversing the effects of climate change as well with its Climate Action Plan, so investing in new buildings would help address this concern that impacts our nation and world. There needs to be concrete action steps on a citywide scale to replace school buildings that are dilapidated and			

contributing to environmental concerns.

For all these reasons we demand that the Board of Education consider issues of equity, environmental racism and climate change, and a commitment to investing in neighborhood schools by building a new school building and athletic facilities for George Washington H.S. and the 10th Ward community. We have a petition on Change.org that is signed by 2,000 stakeholders that we hope the Board will take into consideration when deciding where to prioritize its capital investments. Please know that the East Side of the city needs and deserves new green schools to help overcome previous pollution and negative health impacts from industry. Thank you for your time.
