1	We need transportation for selective enrollment students if we are genuine about evening the playing field for all students. Without transportation out options are again limited and often times the local school is not the best fit for our child. Please do what you can to assist as this busing issue has added stress and hardship to our family.
2	Hi!! I am a volunteer at one of police ststions?and help out at some of the shelters. There are approximately 400+ children at the American Islam College shelter that are not enrolled at school bwcsuse there is no room at sny of the three schools nearby. We had called and I was personally advised that they would need to register next year becausecthere?was no capacity.
3	Migrants' (kids) are not being enrolled in school at AIC. Why isn't there a dedicated person at each shelter ensuring that all kids are enrolled? Families are being told that there is no room.
4	I am writing to voice my concern that our district is not adequately providing bus service for the thousands of children who attend CPS schools. Busses have been historically a critical part of providing access to school alternatives and supporting families who work. The lack of bus options for the great majority of children in the district places a significant hardship on our families, especially those without the means to provide safe, affordable transportation. While the apparent reason for the lack of busses is a driver shortage, there is also an assumed lack of funds to provide decent wages that will attract drivers. I encourage CPS to invest the necessary funds to, at a minimum, provide buses for those students who do not live in walking from their chosen school and can demonstrate the economic hardship of providing alternate transportation. If we intend to address historic inequities within CPS and provide families choices that allow their children opportunities to advance within the system, buses have to be a part of the solution, now and well into the future.

6	To Whom It May Concern:
	I would like to address some possible misunderstandings based on what I said today as Public Speaker #3 regarding the cancellation of busing for approximately 5,500 general education CPS students. Here is the exact quote (you can watch the video of the board meeting to confirm):
	"We have more solutions, but we need CPS Transportation to work with us as well as provide evidence of a certain mandate that they are citing. We have repeatedly asked for evidence of the mandate that states that general education students cannot be on the bus for longer than one hour, and it has not been provided."
	Note that I am specifically talking about GENERAL education students, not students with IEPs. I one hundred percent support the prioritization of these students and limiting their route to less than 60 minutes. I am asking that general education students be added to routes that are currently running with only a few students on a bus with a capacity of 50 or more. I am not asking to extend the time that these routes run. I am asking CPS to allow parents to drop their children off at pickup locations currently in use for students with IEPs, thus not impacting the current running time of the route.
	I also inquired about the 60-minute rule for general education students because as a parent who is currently in the car for 3.5 hours per day transporting my child to and from school, I would gladly accept a 70-minute bus ride for my general education child, and I think that many parents in my situation would accept it as well.
	It is very difficult to thoroughly explain all of the solutions that I am proposing in two minutes, which is why the group I am a part of, CPS Parents for Buses, is requesting a meeting with members of the CPS Transportation Department as well as the Board of

	Education to discuss our ideas and collaborate on solutions. I believe that we can make changes that benefit everyone.

6. Establish greater transparency between the CPS Board and families of students with unmet needs.

The bus has never worked the same since the Covid shutdown.

School drop off round trip in the morning is 1.5 hrs, same in the afternoon. I have to drive for more than 2 hours in the morning including commutes to work, this is impacting my health due to the added stress and lack of sleeps. One of the families we carpooled with ran into a car accident since the husband has been sleeping only 4-5 hours since school started without bus service. They has no choice but pay for private bus service instead of risking the kids' safety and we have to look for new family to fill their spots but it has been extremely difficult to find one. There are lots of uncertainties that we have to manage due the lack of school buses.

Bus incentive of \$500/month should be an option for all SE and magnet students impacted by no bus services

I would rather students have the chance to get transportation to their schools. Otherwise this seems like an underhanded way to remove all magnet and selective programs or making sure that only the privileged students can attend those furthering inequity in our city and further segregating our city. One of the strengths of CPS is the choices within the system allowing students to focus on what they enjoy (arts, stem, academics, and more) at the elementary school level. The lack of promised transportation to these programs puts young children on public transportation to places that are often poorly served by our existing infrastructure causing long times for anyone who does not have a car.

Skinner North has students coming from all over the city and the fact that there's no bus service provided is disheartening. Please listen to us parents.

The decision to eliminate bussing for select enrollment schools is hurting the most vulnerable students in these schools...precisely who these schools are designed to support. With a shortage of drivers, CPS should have considered consolidating bus stops to reduce drive time rather than disenfranchising thousands of CPS students and families.

Please consider the safety measures of our students who now have had to choose riding the CTA under very stressful and unsafe conditions

Gifted students ARE diverse learners too.

For my student, being in a gifted program is akin to an accommodation. She has adhd and would inevitably be bored and act out in our (excellent!) neighborhood school. This would send her down a different educational trajectory with a negative relationship toward school and education. She would draw resources such as teacher and interventionist time that could be spent on other kids in order to manage her behavior and support her academically. At Keller, she is challenged enough to stay engaged and keep her behavior under control. Kids don't just need SE programs for an advantage for test scores. For many kids, they would not be successful in their neighborhood schools.

You have no idea how this upended our lives..,

I am the gifted coordinator at Pulaski and our families have found the current bussing situation very challenging. We have had 2 families leave our program, and there are nearly a dozen that are seriously considering finding a school that is more accessible.

Pulaski is one of 3 RGC-ELs and it is a vital part of the diverse mix of our school community. Pulaski will not be the same if the number of gifted families continues to dwindle. Please consider every possible solution (increasing bus driver pay, additional stipends for gifted families, etc.) to maintain bussing for our RGC and RGC-EL schools.

School zones were created in CPS in order to give high achieving students from lower income areas the opportunity to attend programs that meet their needs but are not in their neighborhood. Discontinuing Bussing from these areas, contradicts the goal to provide these opportunities to all students.

CPS is causing extreme hardship for families to get their back and forth to schools. If they were going to this they should have warn parents at least six months to a year so parents could try to get their children in other schools. It is traumatic for children to change schools

We have never had a school bus, more than one year in.

Lack of bussing and lack of notice is hurting families on a daily basis. We are longtime selective enrollment parents and took those spots to give our kids better opportunities and were counting on bussing. Many families in their classes, especially those who travel the farthest from low income neighborhoods, are also struggling.

my 13 year old is riding the bus everyday coming back from school. I dont feel safe that she is in a bus by herself with many strangers . We have been attending InterAMerican since my daughter was in Pre-k and the main reason why we agreed for her to go to school that far from our home, was because of transportation. The school offered transportation options and 2 weeks before school started CPS decided to cut down our services. We are spending over \$100 a week for my kid to get to school.

We want the school bus back. It is very inconvenient without school bus this fall. To transport my kid to her school every day have a big negative impact on my work and family life. Thank you for makin our voices heard.

If the diversity, equity, and inclusion agenda is a priority for CPS, how is de-prioritizing transportation aligned with that vision? Neighborhood schools will overcrowd, students with specific needs will go without, and choice will be a thing of the past.

I am struggling currently!

The lack of busing has really caused a lot of stress especially when we applied to selective enrollment counting on the bus service.

Thank you for considering the hardship that pulling buses has caused ALL CPS STUDENTS. Everyone deserves an opportunity to learn in an environment that is appropriate for their academic level and ability, regardless of where they live. The SE and regional gifted centers provide an amazing opportunity for the students who qualify for them and it is completely negligent for CPS to overlook providing these students an adequate way to get to and from school. At the very least, CPS should be providing a safe place for students who live outside of the neighborhood to go before

and after school. If this isn't feasible, then some sort of transportation stipend would go a long way to help defray the cost that many of us are absorbing to provide the necessity of after care for our students in SE programs.

I have 2 kids at two separate schools. They start at the same time. I cant't be in two places at once. One kid is always late. We need the bus! For 6 years My son had the bus and no issue.

It is unacceptable for CPS to have communicated that transportation will not be provided for this and the upcoming school year . This shows CPS's lack of commitment to its students, particularly to RGC and selective enrollment students. Lack of transportation is being utilized as yet another barrier to educational inequality.

The busing situation is an equity issue. By eliminating bus service, CPS is worsening the unequal education system. Many of the poorest performing schools are in Black and brown communities. While many white students served by CPS would receive a good education at their neighborhood schools, our property tax allocations, redlining and historic (and current) widespread segregation limit opportunities for minority children. The bus driver shortage is not an unsolvable problem. Higher wages will entice more people to drive our children to school. This needs to be a top priority of this city's administration—or the administration needs to figure out how to ensure schools in minority neighborhoods have equal resources—facilities, books, technology, teaching aptitude, etc.—to those in white areas.

Students at Selective Enrollment schools must also be prioritized for busses.

Do better.

It is ridiculous not to offer bus. Drivers shortage is not an excuse for cutting the bus service. This should be planned ahead annually but not just before the school year start. Get this issue resolved or step down.

We are both working parents and have to be at work for 8 hrs and lack of bus transportation has resulted in one of us having to leave work an hour earlier in order to drive to school & pick up at 2.45pm. They cannot simply expect the parents to make alternate arrangements at work everyday, without providing bus transportation facilities.

The fair bussing conversation should also include bussing students within 6 miles of the school. The notion of an additional boundary map being imposed on Classical and Selective Enrollment schools is also unfair and unequal treatment that disproportionately affects students who have been admitted to the school.

Please implement the above mentioned changes for our children sake.
