As a parent at Sauganash Elementary I would like to voice my concern for the degree of overcrowding at the school. Classes are at 123% capacity, directly affecting individual learning and adding to teacher stress. Gym time is limited due to overcrowding, also negatively affecting student education and increasing injuries. Lastly the overcrowding forces the school to use hallways for teaching and storage.
