# Outstanding CPS FOIA Requests – Request for Board Assistance

Dear Members of the Chicago Board of Education,

I respectfully request the Board's assistance in obtaining responses to several Chicago Public Schools FOIA requests that remain outstanding well beyond the statutory response deadlines. Despite multiple extensions granted by CPS, several of these requests remain unanswered. The delays now exceed 200 business days in certain cases and reflect a pattern of systemic noncompliance with the Illinois Freedom of Information Act.

Below is the updated delay status report as of March 9, 2026. I respectfully request the Board's assistance in directing the appropriate CPS offices to produce the requested records or issue lawful determinations without further delay.






## 1. Color Coded Compliance Chart
